## SPEAKER BIOGRAPHIES

#### **MICHAEL CAREY**



Michael Carey has been Chairman of the Board of The Housing Agency since 2018. Michael has extensive experience in overseeing State bodies, has been Chairman of Enterprise Ireland since October 2023, having served as Chairman of Bord Bia (2011-2018), and as Chairman of the Grow Dublin Tourism Alliance in 2016. He is the Chairman of The Company of Food (a specialist food investment business, providing equity to start-up and established high-growth food businesses) and is also Executive Chairman of East Coast Bakehouse, Ireland's only commercial scale biscuit manufacturer. He has been involved in several not-for-profit initiatives: Chair of Soul of Haiti Foundation (2009-2015) and of Traidlinks Uganda (2013-2016); Member of the Clinton Global Initiative (2009-2015); and a judge on the EY Entrepreneur of the Year Awards (2013 to date).

#### DARRAGH O'BRIEN TD



Darragh O'Brien TD was appointed Minister for Housing, Local Government and Heritage in June 2020. He is an elected TD for the constituency of Dublin-Fingal. Prior to his election to the 30th Dáil in 2007, the Minister worked mainly in Financial Services and was elected to Fingal County Council in 2004. He was elected to Seanad Éireann in 2011.

He has held various positions within the Oireachtas including Vice-Chairperson of the Public Accounts Committee, Member of the Oireachtas Committee on Justice, Equality, Defence and Law Reform, Leader of Fianna Fáil in the Seanad and Opposition Frontbench Spokesperson on Dublin, Foreign Affairs and Housing.

## **BOB JORDAN**



Bob Jordan is Chief Executive of The Housing Agency, a government body that promotes the supply of housing and helps deliver sustainable communities throughout Ireland. He was previously National Director of the Irish Government's Housing First programme to end long-term homelessness, Special Adviser to the Minister for Housing, and Chief Executive of the national housing charity Threshold.

#### **EILEEN DUNNE**



Eileen is a Senior Training Consultant at Alice, focused on providing training in media spokesperson skills. Drawing on her extensive experience in journalism, she prepares clients for media interviews, ensuring they know what to expect before taking to the airwaves and can handle challenging media questions.

Prior to working with Alice, Eileen spent 42 years in RTÉ, most of it in the Newsroom, where she worked as a Newscaster, covering most of the biggest stories of the last four decades – among them, Queen Elizabeth's visit to Ireland, General Elections, Dunblane, the talks leading to the Good Friday Agreement, and the election and resignation of Pope Benedict XVI. She presented a weekly radio programme, 'The God Slot', and music programmes on RTÉ Lyric FM.

For four years up to November 2014, she was International President of the Association of European Journalists, a voluntary pan-European organisation for journalists with an interest in European affairs.

## **ÁINE STAPLETON**



Áine Stapleton is Head of the Housing Policy and Standards Division, having previously led the Social Housing Delivery Division in the Department of Housing, Local Government and Heritage. She joined the Department in December 2020. She is a career civil servant having previously served in senior management roles including at the Department of Finance, the Department of Public Expenditure and Reform and the Department of Transport, Tourism and Sport.

## ÉADAOIN NÍ CHLÉIRIGH



Éadaoin is the Director of Development Operations with the Irish Council for Social Housing with responsibility for housing development and finance. She is a member of the Housing Agency's board and is chair of the Supply and Affordability Advisory Panel.

Previously, Éadaoin was CEO of Richmond Barracks overseeing its restoration and subsequent opening as a city museum. She was CEO of two regeneration projects in Dublin's south inner city. She holds a Masters (NUIM) in Mediation and Conflict Resolution.

### **RUTH HURLEY**



Ruth Hurley of the Housing Delivery Coordination Office, is the Programme Manager/ Coordinator for the Accelerated Delivery Programme under Housing for All. Currently seconded from Clare County Council to the Local Government Management Agency, Ruth is an architect by profession with 20 years' experience in senior management in the public sector, managing strategic and project management programmes for delivery across housing, corporate and tourism capital investment along with conservation and urban design interventions.

#### **JOHN RYAN**



A speaker, author, entrepreneur, founder and CEO of Healthy Place To Work, John has spent most of his working life consulting with multinational organisations in the areas of Trust, Health, Wellbeing and Organisational Transformation.

Formerly a broadcast journalist and expert trainer, John is a regular media contributor and international speaker on topics including organisational health, resilience, and sustainability.

'Make Work Healthy' is the title of his recent book which he co-authored with Dr. Michael Burchell, and which was published by Wiley in the United States and Europe. It has been translated into Korean and Portuguese with a Spanish translation coming later in 2024.

## **CLAIRE FEENEY**



Claire is the Director for Services and Inclusion at The Housing Agency. Her Directorate consists of Approved Housing Body Services, Local Authority Services, the National Housing First Office, Land Management and Part V, all all of which act as centres of excellence in their given areas to support our stakeholders.

Claire joined Dublin City Council in the late 1980's. She spent time on secondment to the Department of Environment, Community and Local Government computerising Motor Tax Offices and moved back to Dublin City Council in 2003 and had responsibly for a number of the regeneration projects. She moved to the Limerick Regeneration Agencies in 2007 working as the Project Manager for the Physical and Economic Regeneration.

In 2012 Claire moved to the Housing Agency to manage the Mortgage to Rent Scheme nationally and drive the National Housing Strategy for Disabled People 2022 – 2027.

#### **ANN MARIE O'CONNOR**



Ann Marie O'Connor is a Principal Officer in the Department of Housing, Local Government and Heritage where she has responsibility for the Vacant Homes Unit. The Unit, which was established in 2022, has a central role in overseeing, driving and supporting a co-ordinated approach to Pathway 4 of Housing for All - 'Addressing Vacancy and Efficient use of Housing Stock', including advancing specific actions such as supporting delivery of the Vacant Property Refurbishment Grant, by local authorities. Ann Marie has worked in the Civil Service for over 25 years, most of which was in the Department of Social Protection where she worked in both policy and operational areas. She has also worked, on secondment, as a Senior Manager in the Citizens Information Board. Ann Marie has Masters Degrees in Social Policy and in Economic Policy Analysis from University College Dublin.

Having previously worked in emergency accommodation options, transitional programmes, and Housing First, she joined Tinteán Housing as Manager in 2016. Tinteán is an AHB and a specialist gender specific homeless service provider in Waterford City and County. Through her work, Claire has gained particular insight into the experiences of women, along with the unique issues experienced by them in homelessness.

Claire is passionate about providing not just housing solutions, but the right housing solutions. Understanding that safety is a priority concern for women, she works with her team to provide housing through a gendered lens.

### **BRIGID DEENIHAN**



Brigid Deenihan is the Vacant Homes Officer with Carlow County Council since August 2022. In this role she is responsible for Promoting and Leading on various Departmental projects such as the Croí Cónaithe Vacant Property Grant and the Ready to Build Scheme and the Compulsory Purchase Activation Programme involving vacant and derelict properties. She is also responsible for collecting and assessing data in relation to vacant properties, communicating with and advising internal and external stakeholders and collaborating with the Town Regeneration Officer, Local Authority Multi-Disciplinary Team, Communities and Property Owners. Brigid has over 33 years' experience working in the public sector, 21 of which have been in various local authorities.
