SPEAKER BIOGRAPHIES

MICHAEL CAREY



Michael Carey has been Chairman of the Board of The Housing Agency since 2018. Michael has extensive experience in overseeing state bodies and has been Chairman of Enterprise Ireland since October 2023, having served as Chairman of Bord Bia (2011-2018), and as Chairman of the Grow Dublin Tourism Alliance in 2016. He is the Chairman of The Company of Food (a specialist food investment business, providing equity to start-up and established high-growth food businesses) and is also Executive Chairman of East Coast Bakehouse, Ireland's only commercial scale biscuit manufacturer.

He has been involved in several not-for-profit initiatives: Chair of Soul of Haiti Foundation (2009-2015) and of Traidlinks Uganda (2013-2016); Member of the Clinton Global Initiative (2009-2015); and a judge on the EY Entrepreneur of the Year Awards (2013 to date).

JAMES BROWNE TD



James Browne, TD, was appointed Minister for Housing, Local Government and Heritage in January 2025. He was elected to Dáil Éireann in the February 2016 general election as a representative for Wexford. In September 2020, he served as Minister of State at the Department of Justice with responsibility for International Law, Law Reform and Youth Justice.

He has served as the Fianna Fáil spokesperson on mental health, leading initiatives to reform mental health services in Ireland, including the Mental Health (Amendment) Act 2018 and served on the Oireachtas Committee on the Future of Mental Healthcare. He was born in Enniscorthy, Co. Wexford and attended college at Waterford IT, University College Cork and King's Inns. He is a qualified barrister and was called to the Bar in 2006.

MARTIN WHELAN



Martin Whelan is the Chief Executive Officer of The Housing Agency. Previously he served as a senior official at the National Treasury Management Agency (NTMA) for eight years, where he worked across the NTMA's core international funding and investment, corporate financial advisory, project execution, and claims and risk management mandates and affiliate businesses including Home Building Finance Ireland and Strategic Banking Corporation of Ireland. Prior to joining the NTMA, Martin worked for five years as a member of the senior leadership team at the National Asset Management Agency (NAMA) during its critical start-up and growth phase. Martin has also held senior positions in management and business consultancy.

He is a Chartered Director (Institute of Directors) and holds postgraduate degrees in economic policy, corporate and applied governance, and urban planning and development.



SINEAD RYAN



Sinead Ryan has worked as a print and broadcast journalist for over 20 years writing on consumer, property and personal finance matters for the Irish Independent. Sinead presents 'The Home Show' on Newstalk and is an experienced MC, conference host, interviewer and keynote speaker, mainly on business, property and financial topics, including pensions.

In 2009 Sinead set up a not-for-profit organisation teaching teenagers about budgeting and personal finance. Her book, co-written with Frank Conway, 'Cents and Sensibility', was published in 2010. Sinead was appointed to the Pensions Council, a Government Advisory Board in 2015 and to the Probate & Conveyancing Expert Group of the Department of Housing in 2023.

DAVID KELLY

David Kelly is Assistant Secretary in the Department of Housing, Local Government and Heritage with responsibility for Homelessness, the Rental Market and Social Inclusion. His previous roles in the Department include positions as Principal in the Homelessness Unit and in Social Housing Delivery.

She has also influenced policy and process changes locally, driving positive improvements in the county's social housing indicators.

Catherine McGillycuddy is a Development Specialist with the Irish Council for Social Housing (ICSH) and has worked in social housing for 20 years in both the AHB and local authority housing sectors. Under Paul's leadership, Fingal County Council brought over 480 affordable homes to market in 2024.
