### 'Understand Me, Include Me'

The National Housing Strategy for Disabled People 2022-2027 sets out a clear vision – to support disabled people to live independently, with choice and control over where, how and with whom they live, and to make sure housing is accessible, inclusive and supported in the community.

A national campaign 'Understand me, Include me' a continuation of 'Journey to Independent Living' has been launched to raise awareness around the housing options

and associated supports that are available to disabled people who wish to live independently in their communities. A key element of this is communication and the accessibility of this. ### **MUDs Outreach Events**

Throughout September and October The Housing Agency is holding a series of outreach events for stakeholders in multi-unit developments (MUDs). Owners of apartments and homes in MUDs are invited to attend information evenings that aim to help them to take a full and active role in their owners' management company (OMC).

The number of apartments and MUDs in Ireland continues to grow and it is estimated that there may be as many as 10,000 OMCs operating nationally. OMCs are responsible for looking after the shared spaces, facilities and services in a housing development, such as an apartment block.

David Rouse, MUDs Adviser with The Housing Agency, explains: "The OMC is responsible for the repair and maintenance of the common areas of the estate, for example lifts, corridors, hallways, stairs, gardens and car parks. Services for which it is responsible include building insurance, security, cleaning and waste management."

OMCs can face a range of issues, from making sure all owners pay their annual service charge on time and in full, to establishing a building investment fund to replace parts of the building such as lifts and roofs.

Information evenings are taking place in Carrick on Shannon, Galway, Dublin, Limerick and Cork. While events are free to attend, registration is required.


# **Analysis of Approved Housing Body** models in the EU

Approved Housing Bodies (AHBs) are independent, not-for-profit organisations that provide affordable rented housing for people who cannot afford to pay private sector rents or buy their own homes.

The Housing Agency commissioned Housing Europe research to examine how AHB-type bodies operate elsewhere in the EU.

The research report, 'Unlocking Potential – A Comparative Analysis of Approved Housing Body Models in the European Union', looks at examples in Belgium, Denmark, Finland and the Netherlands and shines a light on approaches that are of note to housing policy and practice in Ireland.

### **Climate Impact of Housing**

The housing crisis and the climate crisis are intertwined, and we cannot solve one without addressing the other.

The Housing Agency has published a new report prepared by architect and UCD researcher Philip Comerford entitled 'Embodied Carbon and the Climate Impact of our Housing'.

Current regulations in Ireland focus mainly on the emissions created by the running of buildings, known as operational carbon and measured through the Building Energy Rating system. Less well understood is the carbon emitted through the construction and maintenance of buildings, known as embodied carbon.

An innovative aspect of this study is that, in addition to measuring the environmental impact of dwellings themselves, the surrounding neighbourhood is also considered together with its external landscaping and road infrastructure.
