#### **Eoghan Murphy TD**, Minister for Housing, Planning and Local Government

Before being appointed to Cabinet, Eoghan Murphy served as the Minister of State at the Departments of Finance and Public Expenditure & Reform, with special responsibility for Financial Services, eGovernment and Public Procurement.



#### Michael Carey, Chairman, Housing Agency

Michael Carey has extensive experience in overseeing State bodies, having served as Chairman of Bord Bia (2011-2018), and as Chair of the Grow Dublin Tourism Alliance in 2016.



#### Laura Burke, Director General, Environmental Protection Agency

Laura Burke was appointed as the Director General of the Environmental Protection Agency (EPA) in 2011 and served as a Director within the EPA since 2004. Laura is the Chair of the European Environment Agency (EEA) Management. Prior to joining the EPA, she worked in the private sector. Laura is a graduate chemical engineer of University College Dublin (UCD), holds an MSc from Trinity College, Dublin, is a Fellow of the Irish Academy of Engineering and is a Chartered Director. In 2016 Laura was awarded the UCD Engineering Graduates Association (EGA) Distinguished Graduate Award.



## **Dr Nessa Winston**, Associate Professor in Social Policy in the School of Social Policy, Social Work and Social Justice, University College Dublin

Dr Nessa Winston is Associate Professor in Social Policy in the School of Social Policy, Social Work and Social Justice. Her main research interests focus on sustainable communities and include: alternative approaches to housing provision (e.g. housing co-operatives, co-housing); housing, ageing and older people; food, fuel/energy and transport poverty; and urban regeneration for more sustainable communities. She is a coordinator of an interdisciplinary Working Group on Housing and Urban Sustainability, within the European Network for Housing Researchers. She is the co-founder and member of the Irish Social Policy Association.



#### Krystyna Rawicz, Managing Director, KRA Visionary Project Partners

During her years with Birmingham City Council, Krystyna's work included large scale urban regeneration projects. She joined Hamilton Osborne King, (now Savills) on arrival in Ireland. She has headed up KRA Visionary Project Partners since 2000. More recently, she established KRA Renewables as a sister company, to assist clients in the transition to a low-carbon, energy-efficient, sustainable future.

Paul Hogan, Principal Adviser – Planning with the National and Regional Planning Implementation Division in the Department of Housing, Planning and Local Government

Paul Hogan has responsibility for the provision of professional planning advice within the Department, especially within the Planning Division.
