



Purpose

- Oversight strengthening public confidence in Ireland's planning process
- **Delivery** of better planning services by planning authorities
- Research on planning to assist policy and practice
- Public awareness of and understanding of planning



Research

- Much research being undertaken EPA/ESRI/Housing Agency/HEI's co-ordination key
- Things we need to know to inform next generation of plans...
 - GIS tracking of development patterns to measure the "distance to (NPF) target"
 - Where/what type of housing we are providing vs what we need (HDNA)
 - Climate and planning demonstrating we can measure climate benefits in selecting right policies
 - ▶ ICT innovation to better enable the public to be at the heart of planning 3D visualisation





Plans

- OPR part of Project Ireland 2040 implementation re brownfield targets - tackling vacancy - compact development
- All plans need to be examined and in many cases reviewed in the light of NPF later in 2019 into 2020
- OPR will advise through all stages of plan-making process
- New delivery tools: Project 2040 funds Land Development Agency - Vacant Site Levy - Serviced Site Fund - Housing funds - LG reforms
- Engagement and housing/planning working together will ensure policy alignment/delivery - Directions: last resort



Assessing Plans

- OPR will evaluate plans at strategic level:
 - Pre-plan making stage; (issues papers this is important to play a proactive and positive role)
 - Draft plan/amended draft stages/when recommendations have not been complied with.
- OPR must address climate change, consistency with NPF, RSES, Guidelines issued by Minister under S28 Act, Directives under S29, Directions under S31...
- Housing/Core Strategy co-ordination with NPF is a key criteria...
- Development Plan and Housing Needs Demand Assessment guidance from DHPLG (2019)
- OPR will develop with stakeholders an objective plans assessment methodology
- Location of housing and employment vs climate, urban regeneration, sustainable rural renewal strategies will be key issues to address in next round of plans....





- Only housing delivery in smaller towns is LA??

- Rural Regeneration and Development Fund major opportunity for housing and planning practitioners to play their part

Reviews

- Aimed at regular "health checks" of the effectiveness of our planning authorities performance and outcomes delivered/areas where policy/delivery could be enhanced
- Interactions between planning/housing/community offer huge potential
- ▶ OPR will adopt a proactive approach to PA review function a resource for the sector
- Initial step: develop a review methodology drawing on best practice/enhanced indicators eg Scottish Planning Performance Framework (Draft for consultation by end Sept)
 - Quality of development planning; (comprehensiveness/cohesiveness of plans)
 - Effectiveness in delivery of housing supply matched to effective assessment of need;
 - Efficacy in timescales re project planning and decision making;
 - Performance in dealing with legacies including enforcement; and
 - Feedback from key agencies integral to planning including statutory consultees.
